Location and Guidance

YMCA Family Camp Nawakwa's official address is **13400 Camp Nawakwa Lane, Lac du Flambeau, WI 54538**. Please note that if you enter this address in a map app, you may be directed to our South Camp Lodge. We recommend that guests first visit the Welcome Center, if arriving during traditional business hours.

The Welcome Center is the headquarters of Camp Nawakwa. As you drive down Camp Nawakwa Lane, look for a sign on your left, next to a bear carving (see photo below). Turn into the parking lot, and the Welcome Center will be directly in front of you. The office hours

are generally 9 a.m. to 5 p.m. The Welcome Center's Great Room overlooks the North Camp Beach and is open for use 24/7.



South Camp Lodge is located at the end of Camp Nawakwa Lane. This building was the former dining hall and now serves as a gathering place for various activities during the summer. It also has a large screened-in porch that is a popular gathering place for morning coffee, reading your favorite book, or listening to the calls of our local [loons](#).

The back part of South Camp Lodge is used for staff housing, and we request that you respect their ability to get some rest by keeping the noise down after 10 p.m.

South Camp Lodge is a seasonal building and is only open for use from May 15 through October 15.

Arrival & Departure

During the Summer season, which runs from Memorial Day through Labor Day, campers can arrive any time after 5 p.m. on Saturdays. Campers must check out by 10 a.m. on the Saturday of their departure date. Check-in is at the Welcome Center, located in the main parking lot, where you will receive your cabin key and welcome packet. If you arrive after 8:30 p.m., please proceed directly to your cabin. It will be unlocked, with the key and welcome packet inside.

During the Fall, Winter, and Spring seasons, running from Labor Day through Memorial Day, campers can arrive any time after 4 p.m. unless otherwise agreed upon. Campers must check out by 10 a.m. on their departure date. Check-in is at the Welcome Center, where you will receive your cabin key and Welcome Packet. If you arrive after 5 p.m., please proceed directly to your cabin. It will be unlocked, with your key and Welcome Packet inside.

When it's time to depart, cabin keys should be dropped in the Key Dropbox located in the Welcome Center. If you depart before 9 a.m., you may leave the key in the Key Dropbox at the Welcome Center or on the kitchen counter with the door locked when you leave.

To facilitate seamless turnover of our cabins and maximize campers' time at camp, we ask guests to spend a few minutes sweeping their cabin floors and tidying up the cabin before departure. Instructions and cleaning supplies are provided.

Cabins & Amenities

Cabins are equipped with smoke and carbon monoxide detectors, fire extinguishers, beds, mattresses, running hot water, and electricity. Be sure to locate the fire extinguisher and review the instructions located on it.

Kitchen and Bathroom

A four-burner gas or electric stovetop and oven, microwave, refrigerator, drip coffee pot, toaster, pots and pans, utensils, cutlery, and dishes are provided. Hand soap, dish soap, one roll of paper towels, toilet paper, and two garbage bags are also provided. Additionally, camp provides a charcoal outdoor grill.

What to Bring

- All towels (including dish towels), pillows, and bedding
- Toiletries, including sunscreen and bug repellent
- First aid kit and flashlights

Groceries

Food service is not provided by camp. Groceries and other items can be bought at stores in Minocqua, Woodruff, and Lac du Flambeau.

Clothing & Laundry

Northern Wisconsin weather can vary during all seasons. Please pack appropriate clothing for the changing weather. In the Summer, walking shoes, hiking boots, layers, long sleeves, pants, and rain gear are suggested. In colder weather, warm boots, hats, and gloves are needed.

During the Summer season, on-site, coin-operated washers and dryers are available at the North Camp Laundry (building adjacent to North Camp shower house). Laundry detergent is available free of charge.

Camp Store

The Camp Store is in the lower level of the Welcome Center. It has a limited supply of grocery items, toiletries, and first aid supplies for purchase. Ice cream, pizza, milk, ice, sweatshirts, t-shirts, fish bait, charcoal, firewood, souvenirs, and letter and postcard stamps are also available for sale. During the Summer season, store hours are 9:30 a.m. to 5:30 p.m.

Programs & Activities

Camp provides canoes, kayaks, row boats, paddleboards, life vests, oars and paddles. A basketball court, pickleball court, playground, gaga ball pit, volleyball court, and tetherball are available at North Camp near the Welcome Center.

Mail

Incoming mail can be addressed to 13400 Camp Nawakwa Ln., Lac Du Flambeau, WI 54538. Please come to the Welcome Center if you are expecting mail.

Parking

There are designated parking areas in North Camp and South Camp. Most cabins have a driveway in front of their cabin for your personal vehicles. Driveways around and between cabins need to be kept clear for emergency access.

If you are bringing your personal boat, we have two areas designated to park your boat trailer. We ask that you do not leave your trailer at your cabin. Camp staff can direct you to the nearest parking area.

Maintenance Requests

If you have a non-emergency cabin or building maintenance request, please complete the maintenance slip included in your Welcome Packet and drop it off in the office or Camp Store. If you have a maintenance emergency, please contact camp staff immediately.

Internet & Cell Phones

Please note that cellular phone coverage in the Northwoods can be quite limited, allowing and empowering campers to enjoy uninterrupted quality time with their group.

Wireless internet is available in the Welcome Center and the South Camp Lodge. Instructions to access our wireless internet can be found at each location.

Boat Rental Program

Campers can rent pontoon, fishing, and motorboats at a discounted rate from camp. Boats are available on a first-come, first-served basis. Reserving boats prior to arrival is recommended.

Pets

Camp Nawakwa welcomes dogs, cats, and birds as companions for their human campers. Please note that pets are prohibited on the two beaches and inside the Welcome Center, Camp Store, and South Camp Lodge.

All campers intending to bring pets for their visit must sign and comply with the Pet Registration and Waiver. Breed restrictions apply; please see Pet Registration and Waiver document below for details.

Policies & Procedures

All campers and guests must sign the YMCA of Metropolitan Chicago Facility User/Visitor Agreement before being on-site. This agreement is part of the registration process. If this agreement is not completed before arriving at camp, all campers and guests must sign it upon arrival at the Welcome Center.

Emergency Information

Emergency numbers are posted in each cabin and next to the phones in the Welcome Center and South Camp Lodge. Each cabin has a specific fire code number. Please provide this number to emergency services.

If emergency services are called to camp, please subsequently contact our Program Director at 765-652-0898. Staff will help direct you to the next steps. A staff member or camper will be stationed at each road intersection to direct emergency services to the location.

The nearest hospital is Howard Young Medical Center in Woodruff: 715-356-800.

Automated External Defibrillators (AEDs) are in the North Camp Welcome Center and the

South Camp Lodge near the coffee maker. Please ask camp staff if you have any questions.

In an emergency, please call 911. Please refer to the red, laminated sheet in your cabin. Give the dispatcher the cabin number and then contact the camp staff so they can help direct first responders to the proper location.

Reporting Injuries, Accidents & Emergencies

Camp does not carry medical, accident, or loss of personal property insurance for any campers or guests of campers. All injuries, accidents, and emergencies must be reported to camp staff promptly. Campers must provide camp with all copies of reports generated by accidents, incidents, injuries, or property damage involving campers, volunteers, and staff.

First Aid Kits

First Aid Kits are in the Welcome Center, South Camp Lodge, and at various program areas.

Inclement Weather, Fire & Missing Persons

The health, safety, and wellbeing of our campers, guests, and staff is our highest priority.

In the event of severe weather, forest fire, or a missing person, camp staff will communicate and provide directions and instructions to all guests.

In severe weather conditions, such as a tornado, South Campers should move to the South Camp bathhouse, and the North Campers should move to the Welcome Center basement or the North Camp bathhouse.

If power is lost, camp staff will immediately call our utility provider. It may take several hours for electricity to be restored. In this interim period, automatic generators will provide power to the Welcome Center and North and South Camp bathhouses for camper use.

Alcohol, Drugs & Smoking

Illegal drugs are prohibited. Alcohol may be consumed and stored in cabins. Smoking for adult campers is prohibited in all buildings, cabins, beaches, and boat-in-breakfast sites. Wisconsin law prohibits the possession and use of marijuana.

Firearms, Weapons & Fireworks

Fireworks, firearms, and other weapons are not allowed on camp property. The camp Executive Director is the sole decider as to whether an item is considered a weapon.

Supervision of Children

At all times while at camp, adults are responsible for the supervision of their children under the age of 18. Programs are designed for group participation. Adults must supervise children while swimming and boating, even if a lifeguard is on duty.

Quiet Hours

For the comfort and consideration of all campers, quiet hours begin at 11 p.m. Any loud music, conversations, games, and other loud sounds should cease.

Campfires & Grills

Fires are only allowed in pre-made campfire rings/areas or in grills. Campers are not allowed to create new firepits. Campers must use proper safety protocols, including adult supervision, water supply available, no horseplay, and proper extinguishing of the fire. Fires should not be left unattended. Camp staff reserve the right to extinguish a fire if safety protocols are not followed. Camp reserves the right to charge additional fees for firepit clean-up as needed.

Respecting Nature & Wildlife

Camp is made beautiful by everyone respecting the natural wonders found here. Trees and other plants should be viewed and not touched. Carving, breaking branches, peeling bark, driving nails and other materials into trees, and cutting or hacking at trees are prohibited.

The animals found on camp are wild. Do not approach or touch them. It is best to enjoy observing them from a distance.

Cabin Cleaning

Cabins must be left in a respectable condition at check out. All personal items should be removed, dishes cleaned, trash and recycling removed, the refrigerator emptied, and floors swept. A complete list of cleaning directions is posted in each cabin. The camp reserves the right to assess a cleaning fee of up to \$250.00 plus damages for cabins that are left in poor condition.

Trash Removal

Dumpsters for garbage and recycling are between North Camp and South Camp. Please deposit all garbage and recycling in the applicable dumpsters during daylight hours to avoid encountering wild animals, including black bears. Once garbage and recycling are deposited in their respective dumpsters, please make sure that the lids are closed completely. If dumpsters are full or overflowing, please contact camp staff immediately.

Fish Cleaning House

Cleaning fish in cabins is prohibited. The Fish Cleaning House is in South Camp and should be used to clean fish and other seafood.

YMCA OF METROPOLITAN CHICAGO GUEST WAIVER

I agree to follow all rules and regulations of the YMCA of Metropolitan Chicago ("YMCA") while in, upon or about the premises or while using or observing the premises or any facilities or equipment, or participating in any program affiliated with the YMCA without respect to location, whether in-person, remote, or virtual, and understand and agree that I may be expelled at any time, with no refund of any monies paid, for failure to abide by such rules and regulations. I agree that I am responsible for the supervision of my minor child/ward while using or observing the premises or any facilities or equipment, or participating in any program affiliated with the YMCA, where the YMCA is not expressly providing direct supervision as part of specific program objectives, of my minor child/ward without respect to location, whether in-person, remote, or virtual.

IN CONSIDERATION OF BEING PERMITTED TO UTILIZE THE FACILITIES, SERVICES AND PROGRAMS OF THE YMCA FOR ANY PURPOSE, INCLUDING, BUT NOT LIMITED TO, OBSERVATION OR USE OF FACILITIES OR EQUIPMENT OR PARTICIPATION IN ANY PROGRAM AFFILIATED WITH THE YMCA WITHOUT RESPECT AS TO LOCATION, I HEREBY AGREE TO THE FOLLOWING:

1. I UNDERSTAND THAT ACTIVITIES AT THE FACILITY OR ELSEWHERE, INCLUDING USE OF EQUIPMENT AND PARTICIPATING IN PROGRAMS, CAN INVOLVE MOVEMENT, STRAIN, EXPOSURE TO ILLNESS, OR INFECTION, AND OTHER ELEMENTS THAT CREATE RISK OF SERIOUS INJURY OR DEATH. I HEREBY ASSUME FULL RESPONSIBILITY FOR THE RISK OF BODILY INJURY, ILLNESS, INFECTION, DEATH, PROPERTY DAMAGE, OR ANY OTHER LOSS, regardless of severity, that I or my minor child/ward may sustain from my or minor child/ward's presence in, upon, or about the premises or while using or observing the premises or any facilities or equipment, or participating in any program affiliated with the YMCA without respect as to location, except for any injury, damage or loss that is caused solely by the YMCA's gross negligence.

2. I, FOR MYSELF, ANY PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS AND NEXT OF KIN, HEREBY FULLY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the YMCA, its operating centers, their respective Officers, Directors, Managers, Trustees, Members, Volunteers, Employees, agents, or representatives (the "Releasees") and each of them from any and all claims for injuries, illness, damages, or losses that I or my minor child/ward may have or which may accrue to me or my minor child/ward from my and/or my child/ward's presence in, upon, or about the premises or while using or observing the premises or any facilities or equipment, or participating in any program affiliated with the YMCA without respect as to location, except for any injury, damage or loss that is caused solely by the YMCA's gross negligence.

3. I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, or cost they may incur from my or my minor child/ward's presence in, upon, or about the premises or while using or observing the premises or any facilities or equipment, or participating in any program affiliated with the YMCA without respect as to location except for any loss, liability, damage, or cost that caused solely by the YMCA's gross negligence. I further expressly agree that the foregoing ASSUMPTION OF RISK, RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Illinois and if any portion thereof is deemed or held invalid or unenforceable, it is agreed that the remainder of this agreement shall continue in full legal force and effect.

YMCA FAMILY CAMP NAWAKWA WATERFRONT POLICY

All campers and guests of campers must abide by this policy. Please read the following in its entirety.

Adults are responsible for supervising children under eighteen (18) while swimming, boating, on the ice, and participating in waterfront activities. Camp's shoreline rests on a public lake. All adults must familiarize themselves with and adhere to Wisconsin Boating Laws and Regulations. Copies of the Wisconsin Department of Natural Resources boating and fishing regulations are available at the Camp Store.

Fishing

All campers who wish to fish must abide by Wisconsin Fishing License regulations. Children fifteen (15) years and younger and adults born before 1927 do not need to obtain a fishing license. All others must obtain a license, which can be done online at Wisconsin Department of Natural Resources website.

Swimming & Waterfront Use

1. A lifeguard is on duty at the North Camp and South Camp swimming beaches during the summer season from 10:00am – 6:00pm, Sunday – Friday. Lifeguard hours vary on Saturday. Lifeguard hours are posted at the North and South Camp lifeguard stands. These hours are subject to change depending on weather and camper occupancy. Hours will be posted in the program schedule in your Welcome Packet. Please check with Camp staff for confirmation on when a lifeguard will be on duty.
2. When a lifeguard is not on duty, swimming is at the risk of the Camper, children, and adults. Signs stating, NO LIFEGUARD ON DUTY. SWIM AT YOUR OWN RISK! Are posted when a lifeguard is not on duty.
3. All children must take a swim evaluation to determine the child's skill level. Each child will receive a wristband designating the child's skill level. These wristbands correspond with the distance the swimmer may proceed from the shoreline. If a child's skill level is not deemed safe for certain water depths, that child must wear a United States Coast Guard (USCG) approved personal flotation device (PFD) while swimming. Children are required to wear wristbands when on the waterfront.
4. Excessive breath-holding and prolonged underwater swimming are prohibited.

Boating & Watercraft

It is the responsibility of all boat and watercraft operators to know and abide by all Wisconsin boating regulations.

1. Every boat, canoe, paddleboard, and kayak must have at least one wearable USCG approved PFD for every person on board. All children ages twelve (12) and under must wear a USCG-approved PFD while in/on a watercraft. PFDs should be worn, snugly, and properly secured. All rowboats and rental boats must always have a throwable seat cushion onboard.
2. Life vests or PFDs and throwable cushions are available at North Camp, South Camp, and Sugarbush.

3. Campers bringing outboard motors must use rowboats Lowe #10, #11, #20. These boats have been registered by Camp for outboard motor use.
4. Motor and ski boats must maintain a minimum distance of 200 feet from swimming areas, shores, docks, canoes, sailboats, and all other non-motorized watercraft. Motorboats, tubers, and skiers need to stay in the designated ski areas on the lake and adhere to the waterfront policy.
5. Boat and motorboat operators should acquaint themselves with all dangerous rocks and reefs.
6. When operating boats at night, proper running lights must be turned on. Boats must not exceed trolling speed.
7. Inexperienced watercraft and boat operators must take the Wisconsin DNR Safe Boater Course.
8. All Camp and public No Wake areas must be respected.

Miscellaneous

1. Alcohol is not allowed on beaches.
2. No boats, canoes, kayaks, or paddleboards are allowed in the swimming areas.
3. Fishing is not permitted in the swimming areas nor off the swimming docks.
4. Pets are not permitted on the North and South Camp beaches nor the swimming areas.
5. Running, pushing, and other horseplay is prohibited on piers and rafts.

Ice

During the winter, no ice is 100% safe. Campers use the ice at their own risk.

Campers are responsible for their pet’s behaviors at all times.

Please note that the Lac du Flambeau Reservation Animal Control Ordinance (50.307) restricts the following dog breeds within the reservation: Doberman Pinscher; Pit Bull; Rottweiler; American Bulldog; and Akita. Please note that there is a local ordinance that Camp Nawakwa and its Campers must comply with.

Initial each statement below:

_____ I agree that my pet has received and is current with all required immunizations and shots. My animal shall always have its current rabies tag visible. Records of required immunizations must be available upon request by YMCA staff.

_____ I agree to pick up my pet’s waste and dispose of that waste in the outdoor garbage receptacles.

_____ I agree to always keep my pet with me or a designated individual. I will not leave my pet unattended in my lodging.

_____ I agree to pay the \$150.00 pet fee at check in. This fee is nonrefundable.

_____ I agree to keep my pet on a leash of reasonable length or in a carrier while on the property and in public areas unless otherwise designated. Prohibited areas include the two beaches and inside the Welcome Center, Camp Store, and South Camp Lodge. Service animals are permitted in these spaces. Emotional support animals are not considered service animals.

_____ I agree to accept full responsibility for any and all damages, harm, and/or unusual degree of soiling caused by my pet during my stay.

_____ I agree to pay any additional cleaning or repair bills should they be required and authorize the YMCA to charge my credit card for such charges, even if they are discovered following my departure. This includes, but is not limited to, odors, stains, excessive hair, and flea treatment of lodgings.

_____ I agree to prevent noise or any other disturbance by my pet, in the interest of other guests.

_____ I agree that, should my pet create any disturbances, which cause complaints to be made to the YMCA by other occupants or staff, at the request of the Camp Executive Director, I shall immediately make arrangements to board my pet elsewhere off the property or leave the property with my pet without reimbursement. I also agree that YMCA staff have the right to use precautionary and/or reactionary measures if my pet becomes aggressive towards other guests or staff. YMCA staff, in their sole discretion, have the right to request the immediate removal of my animal; if such a request is made, I agree to comply.
