YMCA Camp MacLean – 2024 Terms & Conditions for Overnight Winter Camp

I/We approve this registration and agree to follow camp policies and procedures set forth in the 2024 YMCA Camp MacLean Parent Guide.

I hereby give permission to YMCA Camp MacLean to transport the child named above off the camp property for the purpose of medical care or program activities as deemed appropriate by the Camp Director. I hereby authorize the camp RN to provide for and secure treatment of all health issues that arise at the camp for the child named above. In the event I cannot be reached in an emergency, I give permission to the physician selected by the camp director to hospitalize, secure proper treatment for, and to order injection, anesthetic or surgery for the child named above. I understand the YMCA of Metropolitan Chicago does not carry medical, accident, or loss of personal property insurance for any program participants. Medical bills, including prescription drugs, will be the responsibility of the parent or guardian named below. If applicable, I authorize YMCA Camp MacLean to use my credit cards on file to pay for medical bills and/or prescription drugs.

The YMCA of Metropolitan Chicago has my permission to use photographs taken of my child while at camp for promotional purposes without compensation.

Rules for campers are the same for everyone without regard to race, color, national origin, gender, or disability. I understand that all campers will be treated as individuals and respect will be shown for a range of abilities and behaviors. I agree that Camp MacLean reserves the right to dismiss a child from camp whose needs they are not able to provide for or whose conduct is not in the best interest of the camp community, without a refund. I will notify the director if my child has any serious restrictions related to his/her participation in the camp program. I understand the YMCA is not responsible for lost, stolen, or damaged personal items. I understand that Camp MacLean has policies prohibiting recreational drugs and alcohol. If my child is sent home for disciplinary reasons, I agree to have my child picked up from camp within five hours of being contacted. I agree to the following policies regarding camp fees:

- Fees listed are per child.
- A non-refundable, non-transferable administrative fee of \$125 per camper is due at the time of enrolling. This administrative fee secures the campers' place in winter camp and covers all pre-camp expenses. As such, this \$125 fee is non-refundable and non-transferable in all circumstances, including cancellation by the camp caused by pandemics or other unforeseen situations.
- The administrative fee will be applied to the total fee and the balance of camp fees are due by 12/9/2024. Children who enroll after 12/09/2024 must pay in full at the time of enrolling.
- If I cancel my child's session prior to December 17, 2024, I understand that the camp will refund to me all monies paid except the \$125 administrative fee. If I cancel on or after December 17, 2024, I understand that all fees paid are non-refundable and non-transferable. No refunds or transfers will be given for cancellation on or after December 17, 2024, being dismissed from camp due to disciplinary action, or leaving early due to homesickness or personal commitments. If my child cannot attend camp due to an illness and I cancel on or after December 17, 2024, the camp will refund 50% of all fees paid upon receipt of a physician's written notice.
- I authorize the YMCA to charge fees and amenities to any credit card I have on file with the camp office.

I realize if there is any existing custodial situation regarding guardianship of the child registered above, Camp MacLean staff will only communicate with the parent(s)/guardian(s) listed on the registration form; Camp MacLean staff will not release any information to anyone who inquires about the above-registered camper/child. It is up to the individual(s) that registered the child to share information with any other custodial parent(s)/guardians who may be sharing custody of the above-mentioned child.
