Dear Friends of the YMCA,

Over a century ago, Dr. Luther H. Gulick proposed a red triangle as the YMCA symbol. Its equal sides, according to Gulick, stood for every individual's "essential unity — body, mind and spirit — each being a necessary and eternal part."

Although originally spoken in 1891, those words ring as true today as ever before. The YMCA of Metropolitan Chicago is uniquely positioned to encourage health and well-being in the broadest possible terms, approaching the development of the whole person with programs that strengthen spirit, mind and body.

We create positive results in the way we design and implement our programs, attending to one or more of Dr. Gulick's three "eternal parts" at once, for instance:

Healthy Kids After School programs combine recreation, health, physical activity, tutoring and even mentoring in a joint venture between YMCA centers and Chicago Public Schools — effectively blending regimens for spirit, mind and body into a whole-kid approach to youth development.

Life Development Centers, such as Lawson YMCA—where we provide housing for 583 low-income people—lift spirits and encourage hope by meeting basic needs such as shelter, clothing and food, and expanding upon them with psychiatric support and substance abuse prevention and treatment.

Commit to be Fit, a free one-on-one fitness coaching program, encourages hundreds of city and suburban members to adopt healthier lifestyles, providing moral support and encouraging weight loss for a general sense of wellness and improved energy.

We continue to expand our capacity to help build brighter futures. Last summer we broke ground on the Rauner Family YMCA which will serve Chicago's Pilsen, Little Village and Back of the Yards neighborhoods, and address new community needs as diverse as the people within them. At the same time, our financial performance and outlook continue to improve, further poising our Association for increased service in 2005 and beyond.

Throughout the rest of this report, we will highlight individual programs that affect the spirit, mind and body. Words and numbers — the raw materials of annual reports — cannot convey the look in the eyes of a child who has just learned to swim, an adult who acquires a new skill, or a senior whose outlook takes a turn for the better. That look of hope and possibility represents everything we seek to achieve.

The YMCA of Metropolitan Chicago is dedicated to helping everyone we serve live happier, healthier and more productive lives. Thank you for your support of our work and your continuing commitment to strong kids, strong families and strong communities.

Mission Statement

The YMCA of Metropolitan Chicago is an inclusive, charitable association, founded on Christian principles and dedicated to building strong kids, strong families and strong communities through programs that develop spirit, mind and body.

We provide seniors with a supportive new home.

In September 2004, we opened two 60-unit residences for low-income seniors, under the U.S. Department of Housing and Urban Development's 202 – Supportive Housing for the Elderly Program. The Fred C. Matthews III Senior Housing Center in Chicago's Grand Boulevard community is named for our former Senior Vice-President Fred Matthews, whose 38-year YMCA career enriched our Association and the city at large. In Roseland, on the far south side, we opened the Emil Jones Jr. Senior Housing Center in honor of Illinois Senate President Jones, a long-time friend of the YMCA. Together, these two housing operations represent a \$13.2 million investment in these communities that will serve low-income seniors for decades to come.

We give young adults brighter futures.

In June, we opened a transitional home for south suburban homeless young men ages 18 to 21. The YMCA Network's Independence Place in Midlothian demonstrates the kind of public-private collaboration that the YMCA effectively forges on behalf of those who need a helping hand. Independence Place will provide 10 to 12 residents with on-site staff assistance, counseling, budget management, life skills development, employment assistance and education support to help them become self-sufficient.

We celebrate positive role models.

In 2004, *Chicago* Magazine named Kenny Ruiz, the Executive Director of the YMCA's Street Intervention Program, one of six Chicagoans of the Year. This honor recognized his persistence, sensitivity and bravery in saving lives by leading troubled youth away from gangs, crime and violence. Dedicated heroes like Kenny Ruiz exhibit the level of commitment and involvement to which we all aspire in our efforts to strengthen family and community life.

We show kids other worlds, and vice versa.

In 2004, more than 46,300 children attended our four YMCA resident camps, as well as day camps and outdoor education programs, teaching them new skills and offering them an experience they will never forget. In addition to \$136,000 from the YMCA of Metropolitan Chicago, another \$217,000 was raised to provide full and partial scholarships to over 1,100 low-income campers from the inner city and suburbs. Every child that participates in a YMCA medical camp — for children suffering burn injuries, diabetes, asthma, Tourette syndrome or bereavement — receives at least a partial scholarship. Our four camps hosted 41 international staff from Uganda, Ukraine, Moldova, England, Scotland, Canada, New Zealand, Germany, Denmark, South Africa, Poland, Colombia, France, Hungary, Malaysia, Estonia and Russia — bringing a world of positive new influences to YMCA youth.

We care for the health needs of YMCA residents.

Health care services at a value of \$2.5 million were contributed by Northwestern Memorial Hospital to help meet the primary care and mental health needs of YMCA residents. Acute care, preventive care, dental services, the treatment of chronic conditions and mental health services are provided through a variety of programs and clinics. Combined with YMCA residency, these quality medical services restore stability and hope to those most in need.

We supplement education with inspiration.

In our commitment to offer a safe place for kids to learn and grow, the YMCA of Metropolitan Chicago implemented a mentoring program for fourth through eighth grade students at seven public schools in the Austin and North Lawndale communities. The program offers children personal guidance from one of 90 trained mentors, and seeks to improve their academic achievement, strengthen their interpersonal relationships, lower their dropout rates, and reduce juvenile delinquency and gang membership.

We provide a new outlook on life for at-risk youth and their families.

In 2004, several grants for substantial programs enabled the YMCA to offer an array of valuable human services in high-need communities. The Crossroads program reaches and assesses at-risk kids before they have a police record and provides them with family counseling, group activities, structured programming and other supportive resources. Teen REACH minimizes and reduces the risk of gangs, drugs and violence by offering vulnerable teens a meaningful structure of after-school activities.

We help entrepreneurs fulfill their potential.

The YMCA Alliance's Entrepreneurship Development Program serves people with the vision and energy to start new businesses by providing them with technical assistance and the insights of experienced commercial mentors. The program helps residents of the city's job-strapped Austin and Garfield Park communities to prosper as business owners and to expand local employment opportunities for their neighbors. In 2004, we enrolled 105 new entrepreneurs and expanded the program to facilitate the completion of business plans by each graduate.

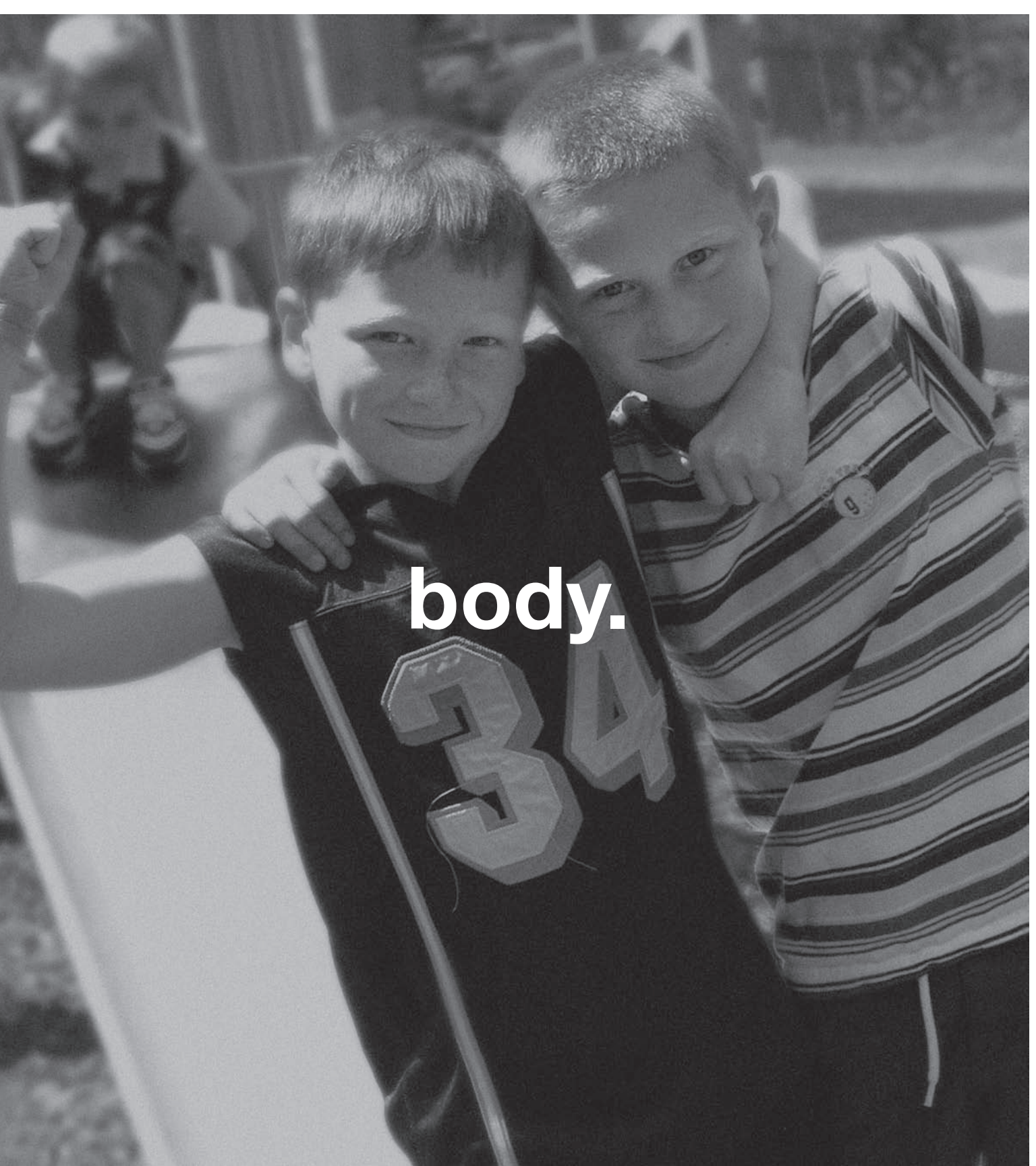
We raise awareness of important health issues for men, women and babies.

Because prostate cancer is on the rise among minorities — especially African-Americans — the West Side Future YMCA expanded its health education programs to include prostate cancer awareness for men living on the west side of Chicago. The West Side Future YMCA also reinforced a comprehensive early prenatal care program that provides outreach, early prenatal education and support to high-risk pregnant women residing in five low-income Chicago Communities: Near West Side, Austin, East and West Garfield Park and North Lawndale. Our goal is to teach the importance of early and regular pre-natal care to prevent preterm birth, low birth weight and other birth defects, thereby reducing infant mortality and improving the overall health of babies.

We remove the obstacles to participation.

In 2004, our Annual Fund raised \$1.4 million to provide scholarships to more than 11,000 individuals and families. It is the goal of the YMCA of Metropolitan Chicago to provide educational, social and physical development services in the communities we serve, regardless of residents' ability to pay. A waiver or reduction of fees is available subject to facility and program capacity and demonstrated need, without regard to race, color, nationality, religion, gender, age or disability.

We want families to make a splash.

In January 2004, we opened the \$7 million von Heimburg Aquatic Center at Foglia YMCA in Lake Zurich. The new aquatic center boasts a 25-yard, six-lane lap pool, a warm water instructional pool, three new locker rooms (two adult and one family), steam and dry saunas, a new aerobics studio, and a separate indoor cycling room. The new facility also increased the size of its wellness center by 70 percent to a total of 10,000 square feet, and added a large preschool room.

We encourage healthy kids.

To begin to address the youth obesity epidemic, in 2002, the YMCA partnered with doctors from the University of Illinois at Chicago. The result was our YMCA Healthy Kids Camp program, where thousands of YMCA summer day campers learned nutrition, education and healthy lifestyle habits through the Y's traditional mix of recreation and fun. Children participated in weekly interactive workshops with doctors, dentists, nutritionists and athletes to gain basic knowledge on being healthier. The success of our Healthy Kids Camp led us in 2004 to expand it into our Healthy Kids After School Program, which takes place throughout the school year. The After School curriculum has been modified to include more Healthy Kids learning components into its programming.

We improve the quality of life for seniors and adults with disabilities.

Third Age YMCA enhances the quality of daily life by providing professional, individualized care and companionship for over 800 homebound, low-income seniors and disabled adults. Without Third Age, many of these elders would be forced into long-term care facilities. Third Age assists them with everyday activities, enabling them to continue to live independently in the safety and comfort of their own homes. In 2004, we sought to expand the reach of this program into the suburbs.

We help you commit to a healthy lifestyle.

The YMCA of Metropolitan Chicago's Commit to Be Fit Program, an individualized fitness coaching program, racked up hundreds of weight loss and fitness successes across the city and suburbs. Elmhurst YMCA Member Karen Biggs took advantage of the free program, working with her Fit Coach to craft a personal regimen that enabled her to drop from a size 20 to a size 14.

2004 Financial Outcomes

The YMCA of Metropolitan Chicago reported an operating loss of \$2.7 million for the year ending December 31, 2004, compared to an operating loss of \$4.1 million for the year ending December 31, 2003.

FY04 operating results represent a substantial improvement in performance over the prior fiscal year. This improvement is the result of on-going initiatives to reduce operating costs, restructure business processes and realign operations to better meet the needs of communities we serve.
