Child & Youth Development: The YMCA of Metro Chicago offers a vast network of programs and services, including early education and care, that provide opportunities for more than 5,000 children to develop and achieve their personal, academic and career goals. The YMCA offers early education, child care, afterschool mentoring, tutoring, and teen leadership programs, such as Achievers.

Camping: The YMCA's day and overnight camps are American Camp Association-accredited, which means the Y maintains the highest standards regarding program quality. Each camp experience nurtures character development through our core values of Caring, Honesty, Respect and Responsibility. YMCA camps transform kids by taking them away from their normal routine and creating a safe and nurturing environment for them to overcome challenges.
